Due to the escalating cost of petroleum related fuel that we have all experienced in recent months, ERG has found the need to apply a fuel surcharge to our transportation and fuel-based equipment items on our invoices. We have been very reluctant to add any additional costs to our customers, especially in these difficult economic times. These surcharges only reflect our additional expenditures to operate our equipment and transportation fleet.

ERG FUEL SURCHARGE SCHEDULE
